NASB Free Distribution Permission Agreement

This Free Distribution Permission Agreement is granted, contingent on the conditions herein, by The Lockman Foundation, a California non-profit corporation, located at 900 S Euclid St, Unit A, La Habra, CA 90631, hereinafter called "LOCKMAN," to Genxr Ltd, a company located at 66 Paul Street, London, England, United Kingdom, EC2A 4NA, hereinafter called "REQUESTER".

REQUESTER hereby agrees that this Free Distribution Permission Agreement is granted subject to the conditions herein and REQUESTER hereby agrees to follow all such conditions.

The English language edition of the NEW AMERICAN STANDARD BIBLE (NASB), Copyright 1960, 1962, 1963, 1968, 1971, 1972, 1973, 1975, 1977, 1995, 2020 is hereinafter referred to as "THE UNDERLYING WORKS".

LOCKMAN grants REQUESTER the non-exclusive worldwide right to REQUESTER make available and distribute THE UNDERLYING WORKS on a website and in an App that are produced by or for REQUESTER titled, "SpeakLife" which is a scripture-based devotional app that helps users pray and speak personalized declarations rooted in Bible verses in digital text form, hereinafter referred to as "THE LICENSED WORKS".

2. THE LICENSED WORKS in whole or part may be accessible by REQUESTER's mobile application either by live data connection or download to the user's device.

As consideration for this Permission Agreement, REQUESTER agrees to provide free promotion of LOCKMAN and the NASB in THE LICENSED WORKS by providing a link to LOCKMAN'S website and/or by other such opportunities that may be reasonably available.

All methods by which THE LICENSED WORKS are displayed and distributed by REQUESTER must be completely free of charge, without any access charges or general membership fees of any kind. An optional subscription for premium features will be also available for a fee provided there is not an additional charge for THE LICENSED WORKS in that version, and THE LICENSED WORKS is available in the free version.
